#### ORGANIZE A PET FOOD & SUPPLY DRIVE TO HELP SPCA FLORIDA ANIMALS

#### For students 13 - 18 years old

Students may collect as many pounds of food as they choose.

- 1. Create posters or flyers for your pet food drive. Please use our Wish List attached. **Do not ask for money**.
- 2. Contact friends, neighbors, relatives, your school and/or church, area businesses, etc. to solicit pet food donations. (SPCA Florida does not encourage students soliciting door to door without parental supervision).
- 3. Email SPCA Florida Volunteer Coordinator, one week prior to make an appointment to drop off the donations: volunteer@spcaflorida.org
- 4. Don't forget to thank those who donated and helped you with this project!
- 5. Once we have received the donation of supplies, the volunteer coordinator will sign any forms required by your school, verifying the project and hours completed. It is your responsibility to present school forms to us with your completed project.
